## **PROPOSED CHANGE TO BYLAWS**

This information was shared in our December Update emailed and posted on Facebook December 3. The timing working out that a recent Facebook post is also being shared, knowing many of our members do not have Facebook accounts. Please keep in mind – typically FB posts are not included in our GRE monthly Update.

The board unanimously agreed to propose a change to the ByLaws – Section 6, which currently reads: Ten (10) members of the Board of Directors present at a duly called meeting shall constitute a quorum. The proposed change is to read: A quorum for Board meetings shall be whoever is present at a duly called Board meeting. A duly called meeting is a meeting time approved by the Community Lay Director and the Community Spiritual director and is announced to the other members of the Board at least 2 weeks in advance by email and text.

Community members objecting to this change must file a petition signed by at least twenty-five (25) community members. The objections must be received within sixty (60) days of this notification. If an objection petition is received, the proposed change will be considered void.

#### WHY WAS THIS CHANGE PROPOSED?

During 2023 we had meetings with less than ten board members present, preventing "live" votes. The GRE board should consist of 12 lay and 3 clergy – a total of 15. If you have been watching the board roster printed in our monthly Updates, you have noticed there's been turnover. For a variety of reasons, several members each year, for the past 2-3 years, have resigned. Due to vacations, family situations, etc., it is not always possible for every member to attend every meeting. In addition, several of our board members are farmers, which makes attending meetings during planting and harvest unlikely (unless it rains). We have done our best to include members who cannot attend in person the opportunity to participate online. However, many farm fields don't have great cell reception – plus, the equipment makes noise, so there are hearing difficulties.

In the December Newsletter the BOD suggested the Board of Directors present at a duly called meeting shall constitute a quorum. The Crown Reunion group is recommending that the following change be made to the GRE bylaws: Article 4 Boad of Directors - Section 6: Six (6) members of the Board of Directors present at a duly called meeting shall constitute a quorum.
