## WALKS #27 & #28

There has been much discussion among the GRE board and community members regarding the upcoming walks.

COVID rates are rising again, and Walks provide a close-knit community. We've all learned over the past year that COVID is an airborne disease – it's transmitted through aerosols. The only way to mitigate is through masks and social distancing. Masks are intended to protect others from the mask wearer's respiratory droplets. Even people who have been vaccinated can transmit COVID. While masks could be mandated, it is not practical that each person will keep one on.

Walks are intimate. Think back to your own walk – the laughter, the singing, the hugs, the tears. Pilgrims, team members, and volunteers gather together for the weekend, eating together, sleeping in somewhat close quarters, and sharing bathroom space.

The board recognizes and appreciates the work and long hours the logistics team, along with the LaMoine staff, put in to organize safe and meaningful walks. Our community members attending the open house left feeling enthusiastic about the upcoming walks and change of venue. A GRE COVID task force was organized and met several times to make recommendations on conducting a safe walk. In the meantime, lay directors have had a challenging time putting teams together and pilgrims sponsorship forms have not been submitted – largely due to COVID fears.

The July board meeting was the last time the board would gather prior to Prep Weekend. Keeping the safety of the pilgrims, team, and volunteers in mind; your board made the difficult decision to postpone Walks #27 and #28.
