#### **Upcoming Walks**

After postponing Summer 2020, Winter 2021, and Summer 2021 walks, it is exciting to think about potential upcoming winter walks.

The following dates are reserved on Quincy University's calendar:

- Men's Walk #27 tentatively set for January 27-30, 2022
- Women's Walk #28 tentatively set for February 24-27, 2022
- Prep Weekend tentatively set for January 7-9, 2022

This past year the Logistics Team spent a considerable amount of time looking at different location options. While the intention was the hold the Summer 2021 Walks at LaMoine Christian Camp, the 2022 Winter Walks will be held at Quincy University.

We can expect changes for upcoming walks. As a result of COVID, Quincy University is implementing new policies and procedures which must be followed by groups utilizing their facilities. We have also learned that costs, such as food, are rising. More information will follow.

Confirmation of meals is required 10-14 days before walk weekends. Currently, ten pilgrims must have their application and non-refundable deposit in the hands of our registrar one week prior to the walk. To help with planning and covering total costs, the GRE Board is working on details to require a minimum number of pilgrims be registered prior to Prep weekend.



Jim Clayton Ladies and Gentlemen, My name is Jim Clayton. I currently serve as pastor for Colchester (which
is where I live) and Hills Grove United Methodist Church(es). I am in my sixth year in that capacity and in my 11th
year as a pastor in the United Methodist Church.

I have a bachelor's degree and an associate degree in Criminology/Sociology from Indiana State University. I spent over 20 years working in the Criminal Justice field.

I am in my 25th year of ministry. I began as a youth director in a small UMC in Terre Haute, Ind. (my home town). I spent 3.5 years as a fully credentialed candidate for Youth for Christ of the Wabash Valley, also located in Terre Haute and serves the neighboring communities in that area.

In the period of time since working for YFC I obtained a two year degree in Biblical Studies, with an emphasis on Youth Ministry, from Rhema Bible College in Tulsa, Oklahoma. I attended my Emmaus walk in the fall of 1993 at Marshall, Indiana. I served that community on several walks as kitchen help, sponsoring candidates, attending candlelight events, working in the Agape Chapel, the workroom, and praying regularly for all involved. I still hold an affinity for that community, as it is in my home town, but it was impractical for me to serve once I moved to Illinois (Rushville) in 2003. Since that move I have served in the ministry full time at several churches: Faith Christian Family Church, Rushville, Ill., Abundant Life Church, La Harpe, Ill., West Prairie Presbyterian Church, Adair, Ill., and La Harpe, Durham, and Terre Haute UMCs, and my current appointment as mentioned earlier. I reentered the Emmaus community here in Illinois when asked by a pastor friend if I would serve as an assistant spiritual director on a Chrysalis walk in 2012, held in Moline, Ill., which I did.

I served that camp as a spiritual director again in 2014, and was slated to serve as a spiritual director for a walk in 2016 which was cancelled. I have been active in the Great River Emmaus Community since being appointed to my current placement in 2017. I served as assistant spiritual director on walks 15 and 19, and filled in for the Obstacles to Grace talk on one other (I have presented the Obstacles to Grace talk and The Prevenient Grace talk two times each). I have attended several candlelight services here and have served in the Agape Chapel on one occasion. I have also hosted two Emmaus gatherings at Colchester UMC and been an active member of the GRE reunion group. My time there has been limited since the spring of 2020 as I enrolled at Asbury Theological Seminary, and have been using my mornings to watch class videos and study.

I am very interested in seeing this group grow and move into a deeper spiritual connection in our surrounding communities. I believe I can be a vital member of the board and help to accomplish those connections. If I were to claim one defining trait that is inherent in my leadership style, I would say that it is my ability to help unify people around the cause of Christ. There is one section of scripture that, in my heart and mind, is the most unifying in the body of Christ.

Mark 16:15 And He said to them, "Go into all the world and preach the gospel to every creature. (NKJV) I truly believe that every single person in the Body of Christ is called to fulfill that commission, and that Emmaus walks are a wonderful avenue to administer it in a great way. And, I am not shy about proclaiming it to be so!
